CALL TO ORDER: 8:00 PM

PRESIDING: Chairman John N. Garrabrandt

PLACE: Board Room, Administrative Offices

PURPOSE: To conduct such old and new business as may lawfully come before the Board of Trustees of a junior college district; to hear reports and care for such other matters as are proper.

THOSE ATTENDING:

Administration: Dr. James L. Taylor, Attorney Bob Alexander, and Secretary-Treasurer Herb Van Slyke.

Visitor: Lee Tremaine of the Times-News.

MINUTES APPROVED: A MOTION was made by Mr. Evans, seconded by Mr. Blastock, and carried, that the Minutes of the Board Meeting of August 16, 1971 stand approved as written.

TREASURER'S REPORT: Treasurer Van Slyke submitted his report covering the activities of the fund accounts of the College during the Month of August.

Upon MOTION by Trustee Evans, seconded by Trustee Blastock, the August report of the Treasurer was approved and accepted as submitted.

BILLS ALLOWED — ONE EXCEPTED: The Board reviewed the abstract of Bills for August, one of which drew exception, and the August Payrolls.

A MOTION was made by Mr. Evans, seconded by Mr. Blastock, that the August bills covered by vouchers #1 through #237 (#238 & #239 voided) be paid, with the exception of #166 to Dr. Roy Shaub for \$7.50, totalling \$161,859.61 with the \$7.50 deducted; that fund transfers covered by vouchers #240 to #248 inclusive, including an investment in Treasury Bills and TCD's of \$499,291.67, be approved; and that August payrolls: Regular \$112,622.72, Work-Study \$10,657.46, be acknowledged.

The MOTION being put to a vote carried without dissent.

PERSONNEL EMPLOYED: Dr. Taylor recommended the employment of the following listed persons:

A MOTION made by Mr. Blastock, seconded by Mr. Evans, and carried accepted Dr. Taylor's recommendations and authorized the employment of those listed above at the salaries set forth.

OLD BUSINESS:

- Under old business Dr. Taylor reported that the contractor has started the glass replacement procedures on the Multi-Use Building.
- 2. 1971 tax levy certified to the counties, the total being more than \$50,000 under the 1970 levy. The new mill levy will figure, based on 1970 assessed valuation, 4.964 for M & O and 2.801 for Bond and Interest as opposed to 5.664 and 2.813 for 1970.

PRESIDENT'S REPORT: Dr. Taylor included the following items in his report.

(1) The white stone facia in front of the air vents on the Shields
Building is all in place according to CTA architects. Last
meeting the Board expressed concern over the appearance of some of
these strips being missing.

- (2) The Council on Education has indicated approval of CSI treatment of faculty salaries and student boarding fees for the 1971-72 contract year.
- (3) The Vo-Tech Building is 50% complete with 40% of the time elapsed.
- (4) The Pell Bill before Congress, under its Title X, provides incentive for setting up a junior college coordinator within the states to help existing junior colleges with basic grants up to \$400.00 annually for each FTE.
- (5) CSI enrollment is now nearing 2800; of these 1300 FTE are academic and 260 vocational.
- (6) North Idaho Junior College and Ricks neither of them have any increase in enrollment for this fall semester.
- (7) The state A-2 basketball tournaments may be held at CSI Gym next February and March.
- (8) Bank deposits, allocation of funds between branch banks were discussed as a result of a question raised by the Board chairman. Rationale for present method of handling was explained.

ADJOURNMENT: No further business to come before this meeting, adjournment was declared at 9:20 PM.
